

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORSICANA, TEXAS, AMENDING CHAPTER 8, ENTITLED *PERSONNEL AND ADMINISTRATION*, ARTICLE 8.500, *MUNICIPAL COURT*, SECTION 8.501, *SPECIAL EXPENSE FEE*, OF THE CITY CODE OF ORDINANCES, AND REPEALING ORDINANCE NO. 2370 AND ORDINANCE NO. 2828.

WHEREAS, in accordance with the provisions of the laws of the State of Texas, the City Council has conducted a public hearing for the purpose of considering the amendment to the Code of Ordinances for the City of Corsicana, Texas; and

WHEREAS, effective January 1, 2020, S.B. 346 amends the Local Government Code to create a new Local Consolidated Fee; and

WHEREAS, the City of Corsicana Municipal Court currently collects the Municipal Court Building Security Fund and the Municipal Court Technology Fund which effective January 1, 2020, will be part of the new Local Consolidated Fee; and

WHEREAS, effective January 1, 2020, Ordinance No. 2370 concerning the Municipal Court Building Security Fund shall be repealed in its entirety as the Fund will be part of the new Local Consolidated Fee established by S.B. 346, Section 134.103 of the Local Government Code.

WHEREAS, effective January 1, 2020, Ordinance No. 2828 concerning the Municipal Court Building Security Fund shall be repealed in its entirety as the Fund will be part of the new Local Consolidated Fee established by S.B. 346, Section 134.103 of the Local Government Code.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Corsicana, Texas, that Ordinance No. 2370 be repealed in its entirety, that Ordinance No. 2828 be repealed in its entirety, and that Chapter 8, entitled *Personnel and Administration*, Article 8.500, *Municipal Court*, Section 8.501, *Special Expense Fee* of the City Code of Ordinances, shall be amended and hereafter read as follows:

CHAPTER 8: PERSONNEL AND ADMINISTRATION

Article 8.500 Municipal Court

Section 8.501 – Special Expense Fine

- (a) There is hereby levied, pursuant to Article 45.203(c), Texas Code of Criminal Procedure, a special expense fine not to exceed \$25.00 against any defendant in the Municipal Court of the City of Corsicana, Navarro County, Texas, for any of the following:
- (1) for an offense under Section 38.10, Penal Code;
 - (2) for an offense under Section 543.009, Transportation Code.

- (b) Money collected for the special expense fine shall be paid into the municipal treasury for the use and benefit of the municipality.
